### **DATASETS**

**The College Experience.** 1996. Survey data was collected from students across three universities located in the southeastern region of the United States (N=860).

**The Intersections of Family, Work, and Health Study.** 2004. In-person interviews were completed with 46 adults and telephone interviews were completed among 86 of their family members (N=132). The 46 families represented in this study include an equivalent number of African American, Hispanic (predominantly Mexican American), and non-Hispanic whites.

**The Well-Being of Chinese International Students** (with Dr. Ethan Michelson). 2019. Data was collected from undergraduate students attending a large midwestern university in the United States (N=35). Before launching the study, the interview guide was reviewed by two consultants whose native language is Chinese. The survey component of the study was presented in English. The in-person interviews were conducted in Chinese by a native Chinese speaker and subsequently translated to English. This project was part of a broader proposal to study the transition into college among a cohort of students, comparing Chinese students who attend college in the U.S. to their peers who remain in China. This project was put on pause in lieu of the COVID-19 pandemic.
